



Allegheny General Hospital (AGH) is the flagship tertiary-care academic medical center of the 10-hospital Allegheny Health Network, located in Pittsburgh, Pennsylvania. As a physician-led organization within Highmark Health, AGH is a national leader in cardiovascular, cancer, neuroscience, orthopaedic, and rehabilitation care, offering a wide array of medical and surgical specialties.

AGH's Department of Pharmacy provides 24-hour comprehensive pharmacy services, utilizing a decentralized, computerized unit-dose drug distribution system and intravenous admixture programs. Technologic processes include robotic sterile compounding, bar-code medication administration (BCMA), radio-frequency pharmaceutical identification (RFID), IV workflow technology, and computerized inventory control. On-site retail pharmacy services including bedside discharge medication delivery (Meds-to-Beds) are also provided.

Pharmacists have direct patient-care responsibilities to ensure the safe and effective use of medications, in addition to supervising supportive pharmacy personnel. Pharmacists with specialized training provide expertise in pharmacokinetics and antimicrobial stewardship, critical care, infectious diseases, cardiology, internal medicine, hematology/oncology, ambulatory care, drug information, transplantation, emergency medicine, and addiction medicine.

Applicants must have graduated from an ACPE-accredited school of pharmacy, have a PharmD or equivalent experience, and be eligible for licensure in the state of Pennsylvania.
